

Bed Bath & Beyond® Campus Ready Sweeps Official Rules

1. Eligibility: Bed Bath & Beyond® Campus Ready Sweeps (the "Promotion") is open only to legal residents of the fifty (50) United States (including District of Columbia), Puerto Rico, and Canada (excluding Quebec) who are at least sixteen (16) years of age and older at the time of entry (each an "entrant"). Limit: Each entrant can earn a total of three (3) bonus Sweepstakes entries during the Promotion Period through the methods described above.
